CG 6486-C ADVISED ON MARCH 10 LAST GIANCANA CONTEMPLATING TRIP, POSSIBLY TO NEW YORK IN NEAR FUTURE. ON MARCH 11 LAST CG 6576-C* ADVISED THAT ANTHONY TISCI, GIANCANA'S SON-IN-LAW, ADVISED THAT GIANCANA HAD NOT LEFT TOWN AS OF THAT DATE, HOWEVER, WOULD IN ALL LIKELIHOOD DEPART ON MARCH 12 LAST. NO DETAILS FURNISHED AS TO POSSIBLE DESTINATION.

CG 6533-C ADVISED THAT GIANCANA HELD NIGHTLY MEETINGS WITH HOODLUM ASSOCIATES FROM MARCH 8 LAST UNTIL MARCH 11 LAST. SINCE MARCH 11 NO ACTIVITY NOTED AT GIANCANA HEADQUARTERS INFORMANT ASSUMES GIANCANA HAS DEPARTED CHICAGO.

NEW YORK REQUESTED TO ALERT LOGICAL SOURCES FOR POSSIBLE APPEARANCE OF GIANCANA THAT CITY ESPECIALLY IN VIEW OF RECENT INFORMATION TO EFFECT GIANCANA MIGHT ATTEND MEETING OF "COMMISSION" MEMBERS RE HIS POSSIBLE REPLACEMENT ON COMMISSION.
