QUINN ADVISED IN HIS INTERVIEW THAT HE HAD KNOWN SPEREN  
FOR MANY YEARS BUT THAT DURING LAST YEAR HE WAS MAKING SEVERAL  
INVESTIGATIONS OF VICE CONDITIONS ON BEHALF OF WILSON AND STATED  
THAT SPEREN WAS HIS INFORMANT. QUINN ATTEMPTED TO HAVE SMITH  
NOT MENTION HIS METTINGS, CLAIMING THAT TO DO SO WOULD JEOPARDIZE  
SMITH AS AN INFORMANT. QUINN ADVISED SPEREN AS A POLICE INFORMANT. ✓
