SAMUEL M. GIANCANA, AKA. AR.

CHICAGO HAS OBTAINED A PORTION OF THE REGISTRATIONS ASSIGNED TO VEHICLES REPORTED BY CG 6533-C AS BEING PRESENT AT ARMORY LOUNGE AT THE SAME TIME AS GIANCANA. REGISTRATIONS RECEIVED TO DATE INDICATE TOP HOODLUMS WILLIE DADDANO, ROCCO POTENZO AND JOHN MATASSA AND OTHERS, HAVE BEEN MEETING WITH GIANCANA ON THE AVERAGE OF TWO TIMES PER WEEK DURING JANUARY, FEBRUARY AND MARCH, 1964. V

INASMUCH AS CHICAGO HAS ONLY RECEIVED APPROXIMATELY ONE QUARTER OF THE REGISTRATIONS OF CARS PRESENT AT THE LOUNGE DURING THE AFOREMENTIONED PERIOD, IT IS ASSUMED MANY OTHER TOP HOODLUMS WILL SUBSEQUENTLY BE DETERMINED TO HAVE MET WITH GIANCANA DURING THIS PERIOD. V

IN VIEW OF LIMITED INFORMATION FROM CG 6486-C\* CONCERNING PERTINENT MEETINGS OF GIANCANA, CHICAGO CONTEMPLATES MAKING REENTRY AT THE ARMORY LOUNGE IN NEAR FUTURE, SOMETIME FOLLOWING APRIL 5 NEXT ON WHICH DATE IT HAS BEEN REPORTED LOUNGE WILL SHUT DOWN TO RELOCATE SOURCE. NOTED THAT ARMORY LOUNGE HAS CLOSED FOR PERIODS OF FOUR OR FIVE WEEKS IN PREVIOUS YEARS DURING WHICH TIME IT HAS BEEN USED ON AN ALMOST EXCLUSIVE BASIS BY GIANCANA FOR HOODLUM MEETINGS. V

CHICAGO WILL KEEP THE BUREAU ADVISED OF ALL PERTINENT DETAILS AS WELL AS CONTEMPLATED DATE OF ENTRY PROVIDING FULL SECURITY ASSURED UACB. V
