SAMUEL M. GIANCANA, AKA, AR.

CG 6486-C* ADVISED THAT HY GODFREY, CHAUFFEUR AND RUNNER FOR MURRAY HUMPHREYS AND FRANK FERRARO APPEARED AT ARMORY LOUNGE AND REQUESTED URGENT MEETING WITH SAM GIANCANA OR BUTCH BLASI, GIANCANA RIGHT HAND MAN. WAS INSTRUCTED GIANCANA AT GOLF COURSE. BLASI, WHEN LATER ADVISED OF GODFREY VISIT, HIGHLY AGITATED AND INDICATED HE DID NOT WANT TO BE BOTHERED WITH GODFREY. SOURCE INDICATED THAT BLASI LATER ADVISED GIANCANA OF GODFREY MATTER AND STATED GODFREY LEFT \$3,000 FOR GIANCANA. OF PARTICULAR NOTE WAS INFORMATION GIVEN TO GODFREY THAT GIANCANA MIGHT BE LOCATED AT PUCCI'S RESTAURANT LOCATED ABOUT TWO BLOCKS WEST OF ARMORY LOUNGE WHERE GIANCANA AND BLASI HAVE BEEN OBSERVED PREVIOUSLY. BLASI FURTHER ADVISED GIANCANA THAT "LITTLE LARRY WANTS TO GET IN TOUCH WITH YOU URGENTLY." THIS IS PROBABLY REFERENCE TO LARRY RUSSANO, CICERO ILLINOIS HOODLUM AND FORMER MANAGER OF JOEY AIUPPA'S TURF LOUNGE, NOTORIOUS CICERO STRIP AND GAMBLING CENTER. IT IS POINTED OUT THAT ABOVE SOURCE INDICATED AIUPPA ATTEMPTED TO CONTACT GIANCANA DURING PREVIOUS WEEK CONCERNING ANOTHER OF HIS CICERO CLUBS WHICH HAS BEEN CLOSED FOR PURPOSE OF HAVING GIANCANA MAKE SOME CONTACTS TO HELP AIUPPA RE-OPEN CLUB. U

WITH UNIDENTIFIED POLICEMAN. GIANCANA ISSUED INSTRUCTIONS TO STEVE TO CONTINUE DICKERING WITH POLICEMAN. ACCORDING TO STEVE, POLICEMAN AFRAID "OF THE G." GIANCANA IN TURN INSTRUCTED STEVE TO TELL POLICEMAN NOT TO WORRY ABOUT G AND THAT THEY WOULD MAKE IT WORTH HIS WHILE. ✓

IT IS NOTED THAT CG 6632-C* ADVISED THAT HY GODFREY ADVISED MURRAY HUMPHREYS THAT GIANCANA COULD NOT MAKE MEETING REQUESTED BY HUMPHREYS FOR JUNE 15 INSTANT AS HE WOULD BE LEAVING TOWN ON EVENING OF JUNE 13 LAST. CG 6486-C* ADVISED GIANCANA STILL IN CHICAGO AS LATE AS 11 PM JUNE 14. THIS WOULD INDICATE GIANCANA MERELY PUTTING OFF HUMPHREYS WITH EXCUSE WHEN NOT INTERESTED IN ~~MAKING~~ MEET. ✓
