SAMUEL M. GIANCANA, AKA, AR.

CG 6486-C* ADVISED THAT GIANCANA RETURNED CHICAGO AREA JUNE 9
 LAST. MET AT ARMORY LOUNGE WITH SEVERAL INDIVIDUALS INCLUDING
 ASSOCIATES CHUCK ENGLISH, BUTCH BLASI AND ROCCO POTENZO.
 GIANCANA ADVISED THAT HE HAD SEVERAL MEETINGS TO ATTEND EVENING
 OF JUNE 9 AND WAS CHAUFFEURRED TO SAME BY BLASI.

MOST PERTINENT INFORMATION WAS THAT CONCERNING COMMENTS OF
 POTENZO WHO WAS MOST INSISTENT THAT HE SPEAK WITH GIANCANA IN
 PRIVATE "TONIGHT." WHEN GIANCANA TOLD POTENZO THAT HE WOULD
 NOT BE ABLE TO TAKE THE TIME HE WAS TOLD "I'LL TELL YOU WHY
 I GOT TO TELL YOU. WHILE YOU WAS AWAY THESE OTHERS TRIED TO
 GET YOU." GIANCANA CURSED AND ADVISED POTENZO NOT TO WORRY. HE
 ADVISED THAT HE COULD TAKE CARE OF HIMSELF. HE THEN INSTRUCTED
 POTENZO THAT HE WOULD BE AT LOUNGE EVERY NIGHT AND POTENZO SHOULD
 CONTACT HIM THERE.

ABOVE WOULD INDICATE POTENZO TOLD GIANCANA OF SOME OF
 ACTIVITIES ON PARTS OF PERSONS NOT IDENTIFIED TO JEOPARDIZE THE
 POSITION OF GIANCANA. IT IS FELT THAT POTENZO WILL FURTHER RELATE
 DETAILS CONCERNING SAME IN NEAR FUTURE.

DURING EVENING BUTCH BLASI HEARD TO ADVISE GIANCANA "HERE IS
 THE MONEY FIFI (BUCCIERI) SENT YOU, \$4,000." NOTHING FURTHER WAS
 STATED TO INDICATE REASON FOR PAYMENT BUT ASSUMED THIS IS BUCCIERI

GROUP MONTHLY, OR POSSIBLY WEEKLY TRIBUTE TO GIANCANA.

CG 6533-C ADVISED THAT JOSEPH (FIFKE) GORNGOLD, WEST SIDE
 GAMBLING OPERATOR ARRIVED AT ARMORY LOUNGE DURING EARLY EVENING
 JUNE 9 LAST.
