INFORMATION RECEIVED FROM CG SIX SEVEN TWO NINE DASH C DASH TE THIS DATE THAT WORD HAS BEEN PASSED TO ALL HOODLUM ~~QUOTE~~ "JUICE LENDERS" ~~END QUOTE~~ THAT THEY ARE TO DISCONTINUE USE OF MUSCLE WITH JUICE OPERATIONS AT THIS TIME AS TOO MUCH HEAT GENERATED ON JUICE ACTIVITIES IN AREA BY FEDERAL AND LOCAL LAW ENFORCEMENT OFFICIALS. INFORMATION DID NOT INDICATE IF PERMANENT OR JUST UNTIL PUBLICITY SUBSIDES.

INFORMANT ALSO ADVISED SAM DE STEFANO, REPORTEDLY CHICAGO'S LEADING MONEY LENDER, HAD ~~QUOTE~~ WORDS ~~END QUOTE~~ WITH SAM GIANCANA AND REPORTEDLY ~~QUOTE~~ TOLD GIANCANA OFF ~~END QUOTE~~. CHICAGO FEELS SECOND INFORMATION PROBABLY CONNECTED TO THAT OF JUICE OPERATIONS AND KNOWING BACKGROUND OF DE STEFANO FEELS IT HIGHLY PLAUSIBLE THAT HE WOULD TELL GIANCANA OFF IN THIS REGARD. CHICAGO FOLLOWING MATTER CLOSELY.

INFORMATION RECEIVED GIANCANA AT AIRPORT WITH BUTCH BLASI NIGHT OF SIX TWENTY FOUR LAST, HOWEVER, NO INDICATION GIVEN AS TO WHETHER GIANCANA THERE FOR PURPOSE OF DEPARTURE OF MEETING WITH UNKNOWN PERSONS.
