GIANCANA OBSERVED CHICAGO AREA JULY 23 LAST.

CG 6533-C ADVISED CONTACT WITH GIANCANA THAT DATE INDICATED HE RETURNED TO CITY PREVIOUS EVENING AFTER SEVERAL DAYS STAY IN NEW YORK CITY. GIANCANA INDICATED TO INFORMANT THAT HE WAS AGAIN PLANNING DEPARTURE FROM CHICAGO BUT DID NOT INDICATE DESTINATION OR ACTUAL DATE OF DEPARTURE.

GIANCANA INDICATED TO INFORMANT HE HAD MET RECENTLY WITH PHYLLIS MC GUIRE AND ADVISED INFORMANT THAT UPON MC GUIRE'S NEXT VISIT TO CHICAGO, HE WOULD INTRODUCE INFORMANT TO MC GUIRE. INFORMANT BELIEVES GIANCANA MEETING WITH MC GUIRE ON CONSTANT BASIS.

AUSA JOHN LULINSKI ADVISED THIS DATE EXTENSION OF TIME GRANTED U.S. ATTORNEY'S OFFICE IN WHICH TO FILE REQUEST FOR REHEARING BEFORE SEVENTH CIRCUIT COURT RE FINDING IN CONTEMPT MATTER OF SAC. LULINSKI ADVISED REQUEST TENTATIVELY TO BE FILED JULY 29 NEXT. BUREAU WILL BE KEPT ADVISED.
