CG6756-C ADVISED RECENTLY VISITED FARM OF SAM BATTAGLIA AT WHICH TIME HE LEARNED THAT BATTAGLIA, WHILE ACTING HEAD OF CHICAGO SYNDICATE WHILE GIANCANA IN JAIL, HAS NO DESIRE TO MAINTAIN THIS POSITION. INFORMANT STATES BATTAGLIA MERELY DESIRES TO CONTINUE RECEIVING HIS CUT OF SYNDICATE PROCEEDS AND WANTS NOTHING TO DO WITH GIVING ORDERS OR SETTLING PROBLEMS, FEELING THAT TO TAKE THIS UPON HIMSELF WILL MERELY CREATE MORE PRESSURE FROM FEDERAL AUTHORITIES. BATTAGLIA FEELS HE HAS SUFFICIENT FUNDS SO HE DOES NOT NEED TO PUSH FOR FURTHER AUTHORITY TO INCREASE HIS WEALTH AND FEELS ADDITIONAL PRESSURE DEFINITELY NOT WORTH TROUBLE. J

INFORMANT CLAIMS BECAUSE OF FOREGOING AND FROM INFORMATION RECEIVED FROM OTHER SOURCES FAMILIAR WITH CHICAGO CRIME GROUP THAT JACK CERONE NOW PROBABLY NUMBER ONE MAN AS FAR AS ISSUING DIRECTIVES AND SETTLING DISPUTES. AS BUREAU AWARE CERONE HAS INDICATED IN PAST HE FEELS HE SHOULD BE NUMBER ONE MAN AND OBVIOUSLY WOULD RELISH OPPORTUNITY TO ASSUME THIS POSITION. U
