CT 6564 - PC ADVISED DURING RECENT CONTACT THAT ONE OF GREATEST FEARS CONCERNING HIS COOPERATION WITH GOVERNMENT IS THAT ANTHONY ACCARDO WILL BE BLAMED FOR WHATEVER PROSECUTIONS RESULTS FROM PC'S TESTIMONY, BASED ON CLOSE FRIENDSHIP OVER PAST YEARS BETWEEN ACCARDO AND PC. PC STATES THAT ASIDE FROM HARM THAT MIGHT BEFALL ACCARDO HE IS CONCERNED THAT SHOULD ACCARDO BE REMOVED FROM POSITION OF TRUST AND POWER AMONG CHICAGO HOODLUMS THAT "THE LID WILL BLOW OFF". PC EXPLAINED ACCARDO IS ONE PERSON RESPONSIBLE FOR KEEPING VIOLENCE AT A MINIMUM IN AREA AND IS ALSO RESPONSIBLE SOME YEARS AGO FOR ISSUING EDICT THAT CHICAGO HOODLUMS ARE NOT TO THREATEN OR CAUSE ANY HARM TO EITHER FBI AGENTS OR NEWSPAPER REPORTERS.

NOTE: Informant who has provided the Chicago Office with information on hoodlum control of Terrell-Clay heavyweight title boxing match advises he is fearful his cooperation with Government may result in blame being fixed on Chicago hoodlum leader Anthony Accardo for prosecutions resulting from informant's testimony. Informant states aside from harm that might befall Accardo, he is concerned in that Accardo considered restraining influence on underworld and if he should be removed from position of trust and power "the lid will blow off." Chicago being instructed to advise informant to continue to furnish information regardless of any anticipated affect on Accardo. U
