MM 1231-C-TE advised SA RALPH R. HILL on 8/23/67, that the recent wave of bombings in Miami and Miami Beach were a result of "orders from MOONEY of Chicago." The most recent of these bombings involved Miami TJT JOHN CLARENCE COOK. On 8/22/67, a bomb exploded in the front of COOK's Miami residence which destroyed his 1967 Eldorado, his 18 foot runabout boat and the front of his residence. On 8/23/67, another bomb was successfully planted in the back of COOK's residence on his 26 foot cruiser, which bomb totally destroyed this craft. U

MM 1231-C-TE advised that "MOONEY" ordered these last two bombings against COOK, and that FRANK "LEFTY" ROSENTHAL received the contract. Informant advised that the cause of dissatisfaction against COOK involved COOK's holding out on some \$300,000 in rare coins which COOK had taken in a series of burglaries over the past several months. H

Regarding the other bombings, "MOONEY" has ordered that all bookmakers in the Miami area be brought under the jurisdiction and control of Chicago and emphasized this authority with the bombing of recalcitrants. Among these were "CHAPPY" RAND, IRVING "MICKEY" ZION and ALPHIE MART, all Miami Beach and Miami bookmakers and all victims of bombing attacks. U

Informant said that these orders specifically excludes the Italian bookmakers and gamblers. Informant was asked if these orders emanated from MOONEY personally and informant was unable to determine this at this time. He states he has no knowledge of MOONEY's presence in Miami, either now or in the recent past. Informant was asked if this information was contrary to the fact that MOONEY had been replaced as boss of Chicago and replied that it was not, but merely indicates that the gambling action which is successfully operated in Miami as a result of these bombings will go to MOONEY and/or the Chicago family. U

Informant advised on 9/4/67, that, with regard to COOK, the contract is now to kill him. An unsuccessful attempt was made on 8/25/67 to shoot COOK and two shots were fired at him, both of which missed. U

Close contact is being maintained with the informant for further details regarding this situation. U
