L On 7/13/67, Mr. JIM BARROWS, newspaper reporter for the"Las Vegas Sun"newspaper, telephonically advised SA JQHN, T. REILLY, JR., of the Las Vegas Division, that PHYLLNS MC GUIRE had purchased the residence at 100 Rancho Circle and the listed valuation of this residence is \$130,000. ANAS BARROWS, who covers the city hall beat, stated he had noted some plans being filed with the City Planning Department, showing that PHYLLIS MC GUIRE is the owner of the residence and she was submitting plans to build a health center on the premises. The building itself will consist of 82 feet, with exercise rooms, etc., plus two swimming pools and a lake on the grounds. might be of interest to the Las Vegas Office in view of MC GUIRE's possible past connections with GIANCANA at the Cal-Neva Lodge.()

BARROWS subsequently contacted the Las Vegas Office and further advised that on 7/13/67, he had been in the office of DON SAYLOR, head of the Planning Commission, and had overheard a conversation between SAYLOR and JERRY MOFFETT, a Las Vegas architect, who had submitted the plans to the planning commission for MC GUIRE. SAYLOR stated that there would have to be a variance of the code due to the size of the building. MOFFETT reported stated, "I can't do that, SAM will kill me."

LV 241-C-TE advised SA JAMES E. DOYLE on 8/16/67, that MIKE DAVIS, current boyfriend of MC GUIRE, was in New York with DAVIS' wife. He advised that DAVIS and MC GUIRE had had an argument, and that DAVIS expressed his desire to cancel out of the home he had purchased for MC GUIRE, in Las Vegas. Informant advised that some time during the past two weeks prior to 8/16/67, DAVIS and MC GUIRE were in Calgary, Canada, vacationing, and had had dinner withhABE SCHILLER, publicity director of the Flamingo Hotel, Las Vegas, who was in Calgary, Canada, on business.

On 9/14/67, SAS M. B. PARKER and JAMES E. DOYLE went to MC GUIRE's residence, 100 Rancho Circle, in an effort to interview her. The maid advised that MC GUIRE was in bed sleeping and would not awaken until shortly before the MC GUIRE Sisters were scheduled to perform at the Desert Inn Hotel.

On 9/15/67, SAS PARKER and DOYLE again went to the MC GUIRE residence at approximately 4:30 P.M., and were informed by the maid that MC GUIRE had just awakened and was not dressed. The maid was instructed to contact MC GUIRE and see when she would be availablee for an interview.

The maid returned and stated MC GUIRE had told her to take the names of the Agents and that she would contact the office to set up an interview. ${\sf V}$
