Representatives of this office have been in daily contact with Attorney JORGE VAZQUEZ ROBLES of Mexican Immigration, and his office has taken no further action in this matter to date. The observations in Chicago teletype 7/27/67, instructions in Bureau cable 7/28/67, and the importance of the relationship between this Office and Mexican Immigration make it inadvisable to try to influence the latter agency to take any specific action in this matter at the present time. It has been repeatedly emphasized, however, that this Office desires to be advised of any pertinent developments regarding subject. (X) u

Action by Mexican Immigration may be hindered by the usual bureaucratic delays and lack of personnel or because the subject may have established a contact for protection while in Mexico. The latter alternative, although a possibility, is purely speculative and unsupported by any information presently available to the Mexico City Office. (X) u

JOAN BANNISTER, Secretary in the office of the Bureau of Narcotics, American Embassy, Mexico City, who visits frequently in Cuernavaca, has advised on various recent occasions that the house at Nubes 2 in Cuernavaca does not give the appearance of being currently occupied. She noted that the house has an upstairs sun deck with shutters and porch furniture and that as of early December 1967 the shutters were down and the porch furniture had been taken in. (X) u

When questioned concerning Nubes 2, DORENBERG only acknowledged that she had handled the sale of this property. She noted that the property formerly belonged to Mr. ANDRES and currently belongs to the company Las Nubes, S.A., which is administered by Attorney JORGE CASTILLO. She would not identify the resident of the address but stated that no one was currently in residence at that address. *Q u*

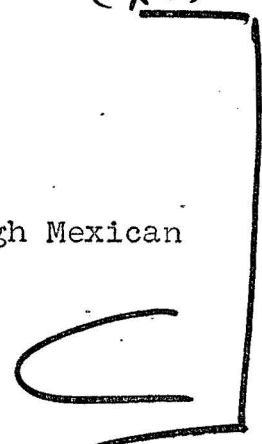
Based on this information, it would appear that subject is not currently in Cuernavaca, and Chicago should be alert to his possible presence in the United States. *# (Q) u*
