On January 5, 1968, the Central Bureau, Criminal Division, Italian National Police (INP), Rome, Italy, advised that GIANFRANCO DONA, owner of the yacht HAMAL (not Hamal III) executed a statement for police authorities on November 14, 1967, wherein he declared he did not know SAMUEL GIANCANA nor was he ever a guest on his yacht *FW*

Italian police authorities are currently trying to locate ANDREA CAMPESI and MANLIO USAI, two of the yacht's crewmen, to verify DONA's statement *FW*

Any additional information received will be reported to the Bureau promptly. *FW*
