Re Mexico City letter December 13, 1967.

The Mexico City Office surveillance informants, MEX 25, MEX 55, MEX 42, and MEX 190 have continued spot surveillances at the Club de Golf and at Nubes 2 and other locations in Cuernavaca, Morelos, Mexico, and also in Mexico City with negative results. They have not observed subject or the Mercedes Benz with Mexico City License 650 SY.

Representatives of this office have been in daily contact with JORGE VAZQUEZ ROBLES, Mexican Immigration Inspection Service, and this matter is frequently discussed. He has indicated a continuing interest but apparently is depending on a source in the Club de Golf in Cuernavaca to notify him if subject is in the area.

VAZQUEZ ROBLES has previously assigned investigations in this matter to MEX 170, who has furnished reliable information in the past and who holds credentials from the Mexican Immigration Inspection Service. This makes it difficult and potentially prejudicial and embarrassing to have this source conduct investigation in this matter independently.

The fact that VAZQUEZ ROBLES continues to be interested in subject and his activities is demonstrated by the fact that he recently requested a name check of a HOLLIS ARTHUR GRIEVE, solely on the fact that this individual had retained subject's attorney, JORGE CASTILLO. VAZQUEZ ROBLES evidently considers anyone who is CASTILLO suspect.
