The following information was received 5/10/68
on a confidential basis from ALFONSO FRIAS, Chief of the
Office of Investigations of the Banco de Mexico. *fu*

He advised that he had arranged for a search
through the records of the Banco Nacional de Mexico
concerning a possible account for the subject with
negative results. *fu*

In addition he had arranged for investigation
to be conducted in Cuernavaca concerning telephone number
2-64-87. *fu*

This number was furnished confidentially by
Inspector JORGE ALDANA as being the telephone located
at Nubes 2 in Cuernavaca. *fu*

FRIAS advised that this telephone number in
Cuernavaca is listed in the name of Aire y Temperatura
(translation-air and temperature), Leandro Valle 501,
Cuernavaca. *fu*

Reportedly the owner of this company is RAFAEL
GONZALEZ de ALVA who has offices in the Casino de Ia
Selva Hotel in Cuernavaca, telephone number 2-17-31.
GONZALEZ also has a private telephone number, 2-39-24.
Supposedly the Aire y Temperatura Company was being
managed by his brother-in-law, but he has not been seen
in the area for about a month. Sources noted that he
had many American visitors. *fu*
