On 8/8/62, GEORGE FUQUA, a notorious Dallas hoodlum who is presently under development as an informant by the Dallas Office, furnished the following information concerning the betting on professional football games. FUQUA would not state his source of this information, but did state he was getting it directly from some Baton Rouge, Louisiana, bookmakers with whom he is well acquainted. FUQUA advised that ~~LEE TAYLOR~~, fullback for the Green Bay Packers, is known to bet heavily and extensively on National Football League (NFL) games. TAYLOR will contact relatives and friends by phone who reside in Baton Rouge and tell them how to bet on certain games. These friends and relatives will then place the bets for TAYLOR with Baton Rouge bookmakers. FUQUA did not indicate that there was anything amiss in TAYLOR's play or that TAYLOR was attempting to fix the outcome of games, but was furnishing the above information about the betting on football games by participating player.

The above information should be handled most discreetly in view of the fact it is unverified, FUQUA's reliability is unknown to Dallas to date, and in order to protect FUQUA's identity.
