SANTO TRAFFICANTE, JR., AKA, AR. DAILY TELETYPE. TONY GONZALO, REPORTEDLY POLITICAL FIGURE CLOSE TO TAMPA CITY ADMINISTRATION, ADVISED JUNE FOURTEEN, SANTO TRAFFICANTE, JR. AND HIS FAMILY LOST ANY POLITICAL SIGNIFICANCE THEY ALLEGEDLY HAD WHEN NICK C. NUCCIO, FORMER MAYOR OF TAMPA, LOST TO JULIAN LANE, PRESENT MAYOR OF TAMPA. BASIL SCAGLIONE, OPERATOR OF UNIVERSITY RESTAURANT, TAMPA, ADVISED HIS BROTHER, NICK SCAGLIONE, AND HIS WIFE, JOSEPHINE, BROKE UP AND NOW DIVORCED, THAT BASIL AND JOSEPHINE NO LONGER IN DREAM BAR, ALLEGED TRAFFICANTE HANGOUT, AND THAT HE WOULD ADVISE NICK TO ALIENATE HIMSELF FROM TRAFFICANTE FAMILY. ESTATE. HE IS PRESENTLY SELLING HIS LIQUOR LICENSE AND DREAM BAR FACILITIES TO FRANK ALBANO WHOM HE KNOWS IS ENGAGED TO LUCILLE TRAFFICANTE, DAUGHTER OF SAM, SUBJECT-S BROTHER.
