SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY.

THE FOLLOWING RECENT DEVELOPMENTS HAVE OCCURRED IN FIRST WARD, CHICAGO, PROVEN STRONGHOLD OF GIANCANA ORGANIZATION. CG 6498 PC ADVISED THAT NEW POWER WITHIN WARD DIRECTLY REPRESENTING GIANCANA IS ANTHONY TISCI, ATTORNEY, SON-IN-LAW OF GIANCANA. HE RELAYS GIANCANA'S INSTRUCTIONS DIRECTLY TO PAT MARCY, FIRST WARD SECRETARY. THIS HAS BEEN CORROBORATED BY CG 6576 C\*, WHO REPORTS DAILY ON THE PRESENCE OF TISCI IN CONFERNECE WITH MARCY. ATTENTION ALSO DIRECTED TO RECENT INFO FROM LATTER SOURCE INDICATING ORGANIZATION DISPLEASURE WITH ANTHONY DE TOLVE, ALDERMANIC CANDIDATE OF FIRST WARD, WHO WILL POSSIBLY BE REPLACED. (u)

CG 6486 C\* REPORTS AS OF FEBRUARY 5 LAST, GIANCANA IS IN CHICAGO. DURING LATTER WEEK OF JANUARY, ACCORDING TO THIS SOURCE, GIANCANA WAS IN MIAMI, WHERE HE WAS IN CONTACT WITH WILLIAM DADDANO. ARMED AND DANGEROUS. (u)
