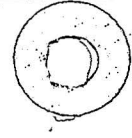
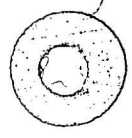

Daily Summary

CG 6498-PC advised 4/17/63 of the following situation regarding GIANCANA's handling of the political situation in Chicago's 28th Ward, of which the informant is Ward Committeeman:

GIANCANA has been displeased with the informant for some time now, since the informant was unwilling to do certain favors for GIANCANA in the past elections. GIANCANA also feels that the informant does not owe complete allegiance to the GIANCANA organization, and for those reasons is giving strong consideration toward ordering the informant to immediately relinquish his position as Ward Committeeman. If GIANCANA so orders, the informant will then go to Mayor DALEY and turn in his resignation. (u)

CG 6498-PC advised that he is certain that AL TOMASO, newly elected Alderman of the 28th Ward, is completely in the pocket of GIANCANA and is co-operating one hundred percent with the organization. The middle man in all these contacts between the GIANCANA organization and the 28th Ward Democratic organization is JOE JAMBRONE, Secretary to the Alderman of the 28th Ward. The informant stated that in his contacts with GIANCANA, the arrangements for the meets were made by JAMBRONE when the informant told GIANCANA that he did not desire to know personally where these contacts were, so that he merely met with GIANCANA after the meetings were set up by JAMBRONE. 92-3171-994
