In the event MARTIN is unable to convince WILLIAMSON of the necessity of meeting with agents in Chicago or New York, MARTIN should determine from WILLIAMSON the city frequented the most by WILLIAMSON during his travels and arrangements can be made through the division covering said city to arrange an appropriate meeting with WILLIAMSON at such times as WILLIAMSON visits the city in question.

It is further pointed out that the Kansas City Division should stress to MARTIN the need for WILLIAMSON to furnish information concerning GIANCANA's activities immediately upon his learning of same so that proper coverage can be afforded these activities. The Kansas City Division is requested to advise MARTIN that should WILLIAMSON desire to make contact with the Chicago Division, he should attempt to contact SA MARSHALL E. RUTLAND to whom the GIANCANA case is assigned.

Should WILLIAMSON continue to be adverse to meeting with agents in either Chicago or New York and a third city be selected by WILLIAMSON, the Chicago Division suggests that the Bureau allow either Chicago or New York Agents to make contact with WILLIAMSON at the designated city, the contacting agents being determined by the proximity to either New York or Chicago. It is felt that the most desirable situation would be for Chicago Agents knowledgeable with GIANCANA's activities, associates, and movements, if at all possible, be allowed to make these contacts.
