GIANCANA indicated that when he leaves NYC he is going to Chicago, then to Hawaii, then to Paris, France.

PCI was then at the airport and was going to Indianapolis and would return to NYC the same day. He will attempt to determine if GIANCANA leaves NYC 6/11/63.

On 6/11/63, PCI advised SAS
ROBERT V. WALKER and CHARLES G. DONNELLY that he first learned GIANCANA was in NYC when he went to Trader Vic's Restaurant following the ED SULLIVAN television show the previous Sunday night and GIANCANA was there. Also present were the MC GUIRE sisters, LOWELL WILLIAMSON, TONY RIPOSA and himself. After Trader Vic's, they went to Jilly's Restaurant.

PCI advised he went dinner at PHYLLIS' apartment the night of 6/10/63. Also present were the MC GUIRE sisters, subject, WILLIAMSON. FRANK SINATRA, three other men, whose names are unknown to ______ and one Negro who came with SINATRA (not SAMMY DAVIS). SINATRA did not stay long and left for Los Angeles accompanied by the Negro. WILLIAMSON, DOROTHY, CHRIS and himself left shortly before midnight leaving PHYLLIS and GIANCANA there alone. ())

PCI said he is driving PHYLLIS' car to Framingham, Massachusetts on 6/12/63, but as yet does not know if the MC GUIRES are going with him. The MC GUIRES have stated they have stayed at the motel at the "Monticello" before and PCI surmises they will stay there again. He will attempt to determine this and contact the NYO prior to departure.

He said he believes he will drive the car directly to Cincinnati, Ohio from Framingham, then to Warren, Ohio; Columbus, Ohio; Lake Tahoe and then to Las Vegas. He does not believe he will go to Omaha, Nebraska with them but after Las Vegas expects to go on to his home in Calgary, Canada. PHYLLIS has indicated she wants her car in the west with her. PCI said that when their tour ends in September, all the girls are going to DOROTHY's home in Calgary.
