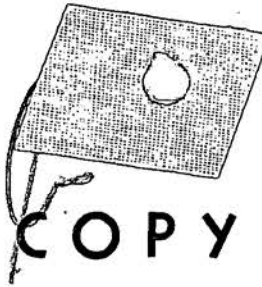
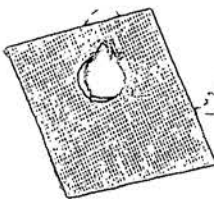

PCI [redacted] ADVISED JUNE 12 INSTANT HE IS LEAVING  
 NYC AT 3:30 PM TODAY ALONE, DRIVING PHYLLIS MC GUIRE'S CAR,  
 A 1963 TAN CADILLAC CONVERTIBLE, NEW YORK LICENSE 8669-C,  
 EN ROUTE TO THE "MONTECELLO" NIGHTCLUB AND MOTEL, FRAMINGHAM,  
 MASSACHUSETTS. MURRY KANE, MC GUIRE SISTERS' MANAGER, IS TRAVELLING  
 BY TRAIN. MC GUIRE SISTERS HAVE NOT DECIDED IF THEY WILL  
 TRAVEL BY TRAIN OR LIMOUSINE, BUT WILL LEAVE NYC EVENING OF  
 JUNE 12 INSTANT. TONY RIPOSA IS ALREADY AT FRAMINGHAM. (u)

 LEAVING NYC ABOUT 7:00 PM TODAY FOR FRAMINGHAM, MASSACHUSETTS  
 VIA LIMOUSINE FOR THE ENGAGEMENT AT THE "MONTICELLO".

[redacted] IS TO FLY TO HOUSTON, TEXAS TO GET HIS CHILDREN THEN  
 GO TO CALGARY, CANADA. HE DOES NOT EXPECT TO COME TO NYC FOR  
 SOME TIME. HE WILL CONTACT EITHER NYO OR SA MARSHALL E. RUTLAND  
 OF CHICAGO OFFICE IF HE LEARNS ANYTHING OF VALUE CONCERNING

PCI [redacted] LATER ADVISED SISTERS TOLD HIM GIANCANA LEAVING
