Before leaving NYC 6/12/63, PHYLLIS MC GUIRE gave PCI a ring which had a loose diamond to bring to KOSLOW's to have repaired. PCI said he is not familiar with value of jewelry, but if uncut 27 carat diamond GIANCANA showed him the other day was worth \$100,000, this ring must be worth two or three times more. 11 brought PHYLLIS' ring to MARVIN KOSLOW, 724 Fifth Avenue, 6/13/63 and had lengthy conversation with MARVIN. He said GIANCANA apparently works with both AL and MARVIN KOSLOW. MARVIN KOSLOW advised PCI that PHYLLIS' ring "is a good stone" but did not place value on it. KOSLOW stated the 27 carat diamond shown to PCI was not his, but was GIANCANA's and he was trying to sell it for him. KOSLOW did not indicate it was stolen. (())

MARVIN KOSLOW indicated he is very nervous because of his relationship with GIANCANA but said "I am not doing anything wrong". KOSLOW said any business he conducts with GIANCANA is reflected on his income tax records. GIANCANA has told KOSLOW what to say if he is ever questioned by authorities and indicated they concocted story that MARVIN had been going with PHYLLIS and in that way became acquainted with GIANCANA.

MARVIN also said that at the Fountainbleu Hotel, Miami Beach, he had met another fellow TOM (LNU)"who is either Sam's boss or the head of another branch".

NY 204-C, who is acquainted with many burglars and dealers in stolen jewelry, advised on 6/13/63, he does not know the KOSLOW brothers. (1)
