This apartment house is owned by the Cosmopolitan Corp., a real estate holding company; the 5775 Collins Corp., an operating company and the Intercontinental Development Corp., an operating builder.

On afternoon of 1/2/62, ANTHONY RICCI (Miami file 92-112) was observed with five individuals and they drove to Hollywood, Fla., where they purchased groceries at the Lititos Italian Market and then drive to 5801 La Gorce Dr., Miami Beach, the home of FRANCIS JEROME CURRY, who has in past been described as the number two man of PAUL DE LUCIA (Miami file 92-123) and a member of the Chicago organization of GUZIK, ACCARDO and DE LUCIA.

Chicago Office on 12/29/61 advised that Chicago informant CG 6232-C, advised that PATRICK FRANK SETTEMBRINO (Miami file 165-7) advised he would like to have a set-up in Chicago where he could have a permanent open phone to get race results from Sportsmans' Park in Chicago, so that he could furnish his customers in Miami with current info as to the race results. According to informant, SETTEMBRINO was providing a service in Florida which he operated out of his home and that he had an arrangement where he had an open wire to Delaware, where he was getting current track results and then with a second phone in his home he supplies these results to his customers.
