If he got a bartender here, he'd tell 'em

what the (obs) you gonna do, nothing.

SIMONELLI:

The above conversation took place between DOMINIC "Butch" BLASI, bodyguard and chauffeur for GIANCANA, and TARQUIN "Queenie" SIMONELLI, who is the brother-in-law of TONY ACCARDO, prominent Chicago hoodlum.

Exact significance of conversation in which reference is made to "boot" is not clear; however, in view of sounds indicating some type manual labor in progress and subsequent reference to delivery of "leads" to JOHN KRINGAS, conversation might possibly refer to some type telephone apparatus. Noted BLASI also advised SIMONELLI that he suggested to SAM GIANCANA that telephone be used for making meeting dates only. JOHN KRINGAS is the owner of Gus' Steak House, a notorious Cicero, Illinois, gambling establishment.

Identity of LOU SHOES, who apparently died 4/10/62 and was known to both BLASI and SIMONELLI, not known to Chicago Office at this time.

Telephone conversation held between BLASI and unidentified person apparently relates to business being conducted at the Eden Land and Building Company, Schiller Park, Illinois, of which BLASI is allegedly Executive Vice President. Noted during interview of BLASI by SA JOHN R. BASSETT of Chicago Office earlier this month BLASI made available a business card for this company claiming it was a successful new venture.

CG 6533-C advised 4/12/62 that the Armory Lounge is officially closed until 4/24/62 and that CARMEN FANELLI, proprietor, has entered hapital for an operation. Conversation relating to ice machine apparently refers to instructions left by FANELLI with BLASI regarding operation of the machine while the Armory Lounge is closed indicating that although the Lounge is closed to the public, hoodlums will continue to conduct meetings there.
