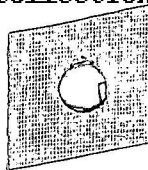
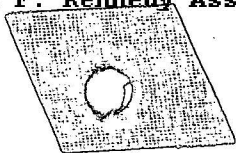

CG 6486-C* reported the following information 9/13/62 and 9/14/62. From the context, it appears that GIANCANA returned to Chicago from Las Vegas, Nevada, 9/12/62.

JOHN FORMUSA is a top hoodlum of the Indianapolis Office and is employed at the present by the CAL-NEVA Lodge, Lake Tahoe, Nevada. It is possible that the conversation between FORMUSA and GIANCANA refers to the impending opening of this establishment. Las Vegas is requested to furnish its comments concerning this.
