to the post of First District Commander. REYNOLDS was desirous of knowing whether MARCI wished to have him have RIORDAN present at this luncheon but was told by MARCI that he wished to discuss the situation with REYNOLDS before talking to RIORDAN. It appeared to the source that REYNOLDS has already, or will by the time of the luncheon, have talked with RIORDAN and determined what his orders are in regard to the strip joints in the Loop. From the information he furnishes MARCI, MARCI will then determine what tack to take with RIORDAN at such time as they meet.

Later in the day MARCI was joined by one SAM (LNU), a Democratic Precinct Captain within the 28th Ward, who met with MARCI to discuss the possibility of his being nominated as the potential Alderman for this Ward. It is pointed out that the former Alderman of this Ward was one ANTHONY GIROLAMI, presently the Clerk of the Probate Court who is identical with CG 6498-PC. Their conversation was as follows:

MARCI:

I know there's a lot of guys shootin' for it. I haven't heard anything about it. If I tell you not to go for it, I might be hurting your chances. There's a possibility.

SAM:

Who can I talk to? I can talk to you, I can talk to JOHN, but there's nobody else.

MARCI:

I don't know if they've got anybody in mind or not. It wasn't discussed yet. Maybe they were waiting to see if TONY (GIROLAMI) was elected. Now they'll get busy. I don't know if they'll take a guy that belongs to the organization or one that doesn't belong to the organization. As soon as I know that they are considering guys I'll let you know about it. Unless you go to TONY and tell him that you'd like to be considered. I think you should.

SAM:

I'd be very happy to do that.

MARCI:

That's where I'd start. Then if he gets to say who it is you got a chance. If he told who it will be that's something else. But up to my knowledge I know it isn't gone yet. I don't even know who's in front. There's so many guys going I don't know who the front runners are.

In reference to the above it is noted that CG 6498-PC has advised concerning several contacts which have been made with him during the past year or so by Chicago top hoodlums, SAM GIANCANA and MURRAY HUMPHREYS. This PCI, who is the leading political power in his Ward, advised SA WILLIAM F. ROEMER last week that considerable pressure has been put on him to lend his influence, which is tantamount to the Democratic nomination and therefore to election, to certain individuals in their campaign to become Aldermen of the 28th Ward, a Ward located on the west side of Chicago in a predominantly Italian section. The PCI has advised that GIANCANA is interested in the nomination of BOBBY PETRONE, mentioned above by MARCI. The PCI also advised that several lesser hoodlums, probably including JOE GAGLIANO, have approached him concerning the candidacy of JOE GARAMBRONE, mentioned above by MARCI. It is noted that GARAMBRONE is presently the PCI's secretary in his Ward organization and is also the brother of MOUSEY GARAMBRONE, who is a chief lieutenant of the GUS ALEX - LOUIE BRIATTA gambling organization in the First Ward of Chicago. However, last week the PCI advised that he has not yet announced it and is keeping it quiet but has decided to lend his support to AL TOMASO. TOMASO was formerly the head of the Chicago Office of the Illinois Secretary of State, is a former school teacher in Chicago, is a graduate of DePaul Law School, is a former student for the priesthood who now has a son studying for the priesthood, and to the knowledge of the PCI has never been tainted by association with hoodlums or by an arrest. PCI stated that he is very sincerely trying to find the best man in his Ward organization contrary to the desires of the hoodlum and gambling interests there.
