## ADMINISTRATIVE

KLOTZ is a subject of Chicago file captioned, "ANTHONY TITO, AKA; ET AL; ITWI; IGB", Chicago file 165-2714 in which Title III coverage on a bookmaking location under the name Unique T.V. Service was commenced 9/14/71, and terminated 10/18/71. During the course of the electronic surveillance, subject was tentatively identified as one of the individuals furnishing sports line information to this bookmaking operation.

## INFORMANTS

On 8/20/71 CG 6187-C advised SA MOBERT L. MALONE that (FNU) KLOTZ and LOUGHTOOPER (LOUIS KOPPLE) bank rolled the biggest sports book in the Chicago area and that the office for this operation is manned by TONE (LNU) (ANTHONY TITO). Source was told by "YUDIE" LUPMAN that KLOTZ, LUFMAN, GUSYALEX, LENNIE PATRICK, and DAVEY ARAS each have a 20 percent interest in this bookmaking operation.

On 9/14/71 informant advised that TONY, who operates the above bookmaking office, has no police arrest record. KLOTZ and HOOPER stay away from the office because they have previous arrests. According to source, this operation pays \$3,000.00 per month to the Vice Control Division, Chicago Police Department, for protection and will accept no wagers under \$200.00.

CG 7495-PC on 10/21/71 advised SA JOHN E. OSBORNE that MORRIS KLOTZ stated he could not go back into sports bookmaking because he is unable to obtain a line. Source remarked that recent gambling raids by the Federal Bureau of Investigation (FBI) were very disruptive to KLOTZ and his bookmaking operation.

Source continued by saying that BENNIE GLICKMAN has been having a personality conflict with TONY TITO for the last month, and GLICKMAN has been attempting to smooth things over by interceding with JIMMA GURGONE. Source said GURGONE appears to be a silent partner with TITO in the sports bookmaking operation.

Informant stated KLOTZ personally handles the accounts of JACK PARKS and JAKEY SOMMERFIELD. HYMAN FINEGOLD was named as a customer of SOMMERFIELD.

CG 7495-PC said it is the belief of the bookmaking group, at the Cavendish Bridge Club, that CHARLIE PERES is responsible for their uncovering by the FBI because he is calling all over the place.

On 10/29/71 CG 7486-C-TE advised SA JAMES D. DEWHIRST that JIMMY (LNU) is TONY TITO's partner in connection with TITO's bookmaking operation.

Source stated that MORRIS KLOTZ meets with friends, associates and bookmakers at 10:00 a.m. on Sundays at the 181 Grill, 181 West Madison, Chicago.

CG 7386-C-TE stated that in connection with the recent raids by the Covernment on the wireroom in which KLOTZ was a partner with TONY TITO, their operation is still down, and they will wait two or three weeks longer before starting up again.

On 11/9/71 CG 7495-PC told SA OSBORNE that KLOTZ was at the Cavendish Bridge Club on 11/9/71.

CG 6187-C advised SA MALONE on 11/12/71 that KLOTZ located and arranged an office to handle six large bookmaking accounts of "YUDIE" LUFMAN. According to source, LUFMAN personally pays off for/or collects from these accounts on Tuesday mornings, usually leaving his home between 8:00 a.m. and 9:00 a.m.
