On 5/31/62, PH 521-C advised subject BUFALINO has been out of town almost a week attending the funeral of a relative in Buffalo, N.Y. Relative is thought to be a brother-in-law.

Subject BUFALINO observed on 5/31/62 in his 1961 Cadillac, parked in front of a hardware store, 500 Main Street, Duryea, Pa. Two other unknown men observed in car; one, the driver, fits the description of "CAPPY" GUIMENTO. The hardware store is next door to "Carmen's Radio and TV Sales and Service," 422 Main Street. This store is operated by CARMEN DI BIASI, who allegedly had money invested in the Orchid Club in Scranton, which is now defunct and later worked part-time as a bartender in BUFALINO's Club 82 in Pittston, Pa.

At 11:45 a.m., BUFALINO's car left this location with unknown driver and BUFALINO as passenger and proceeded to Taylor, Pa. At 12:05 p.m., BUFALINO and unknown companion were observed entering Aldino's Restaurant in Taylor after parking the car across the street.
