Re Phila. letter (FD 142) 10/12/62 and Bureau letter to Phila. 10/17/62.

Phila. letter indicates that cost for leased line to bring source, if same established, into Phila. area would be approximately \$1.00 per air mile and the distance of location of source (to CP in Phila.) is 120 miles.

Contact with confidential source at Bell Telephone Co., Phila., indicates more accurately would be approximately \$3.00 per air mile, which would give end result of monthly cost of between \$350.00 and \$400.00 for leased line.

Considering the above expense, plus cost of manpower to monitor, it is requested that Bureau advise if cost prohibitive or if Bureau desirous of survey continuing.
