BUFALINO only individual observed leaving Seville Bar and returned to Tri-City Textile, Old Forge, and then to residence at Kingston, Pa. U

Efforts on evening 1/4/63 to locate NAKHLEH negative. U

New York telephonically advised ISSA NAKHLEH is Arab member of Palestine-Arab delegation, an non-official delegation. ~~CONFIDENTIAL~~

Captain JAMES MC DONALD, today advised that the PD's informant furnished the following: U

NAKHLEH met with STEVENS, the informant, and one other unidentified person at Wilkes-Barre (place unknown) for dinner 1/4/63 and discussed forming syndicate for purpose of selling slot machines to West Germany and Spain. STEVENS and NAKHLEH have met with finance minister, Germany, and plan to visit Germany in re to proposed transactions. Syndicate, according to MC DONALD, to include all of U subjects.

Allegheny Airlines, Scranton, advised NAKHLEH left Wilkes-Barre - Scranton Airport 3:15 p.m., 1/5/63, for return New York City. U
