CG 6498-CTE ADVISED OCTOBER 16 THAT ON EVENING OCTOBER 15
LAST HE RECEIVED WORD THAT CHANGES ARE IMMINENT IN HOODLUM
GROUP HERE AND THAT ON THAT NIGHT BIG MEETING WAS HELD IN
CHICAGO RELATIVE TO THESE CHANGES. u

INFORMANT ADVISED SAM BATTAGLIA HAS BEEN TAPPED FOR ADDITIONAL
POWER AND RESPONSIBILITIES UP TO AND PERHAPS INCLUDING
REPLACEMENT GIANCANA. HOWEVER, INFORMANT'S INFORMATION NOT
CLEAR WHETHER GIANCANA BEING REPLACED, OR IF BATTAGLIA
REPLACEMENT FOR FRANK FERRARO. INFORMANT ADVISED JACK CERONE
MIGHT HAVE RECEIVED POWER NOW BEING ASSUMED BY BATTAGLIA
EXCEPT THAT HE HAS BECOME "A DRINKING PROBLEM" AND IS ALSO
BLAMED FOR HEAT BROUGHT ON ORGANIZED CRIME HERE BY HIS
UNDERLINGS, JOSEPH GAGLIANO AND WILLIAM MESSINO WHO RECENTLY
TRIED FOR THEIR INVOLVEMENT JUICE OPERATION OF CERONE AND
NOW UNDER PROSECUTION FOR INVOLVEMENT GAMBLING OPERATION
CERONE. u
