 GROUP ARRIVED, PARTY REMAINED STATING THAT GIANCANA WAS TO  
 MEET WITH THEM LATER. SOURCE LEARNED THAT GROUP FROM NEW YORK  
 CITY AND REPORTEDLY WELL KNOWN HOODLUMS. GIANCANA HAD NOT  
 ARRIVED WHEN SOURCE DEPARTED AT MIDNIGHT BUT PARTY REMAINED. u

IN THIS CONNECTION, MARCY ADVISED THAT IN RESPONSE TO  
 CONTACT WITH BUTCH BLASI ON DECEMBER 7 LAST CONCERNING
