CG 6036-C ADVISED DECEMBER 18 GIANCANA PLANNING TRIP TO PERU JANUARY 5 NEXT IN CONNECTION WITH OPENING OF GAMBLING ENTERPRISE IN THAT COUNTRY. THIS INFORMATION HIGHLY PERTINENT IN LIGHT OF INFO RECEIVED FROM CG 6576-C\* CONCERNING REPORT COMPILED BY RICHARD CAIN, FORMER CHIEF INVESTIGATOR FOR COOK COUNTY SHERIFF, RECENTLY CONVICTED FOR PERJURY, DURING RECENT TRIP TO PERU. REPORT GIVEN TO GUS ALEX WHO IN TURN PASSED SAME ON TO GIANCANA. SOURCE ADVISED DURING DISCUSSION OF PROJECT BETWEEN THESE TWO, ALEX ADVISED AGAINST GOING INTO DEAL ON BASIS THAT THEY KNOW LITTLE ABOUT PERU AND THAT VENTURE WOULD BE COSTLY. ALEX INDICATED PROJECT WOULD INVOLVE CONSTRUCTION OF LARGE BUILDING AND OPERATION WOULD NOT BE "A STORE FRONT TYPE VENTURE." NEW YORK ADVISED OF ABOVE FOR CONSIDERATION OF SUBPOENA OF GIANCANA IN CONNECTION WITH BONNANO GRAND JURY. u
