INFO RECEIVED THIS DATE FROM HIGHLY CONFIDENTIAL SOURCE THAT CHICAGO ATTORNEY MIKE BRODKIN ADVISED HE HAD "REACHED OUT FOR MOONEY" ON AN IMPORTANT MATTER BUT LEARNED FROM BUTCH BLASI THAT GIANCANA IS OUT OF TOWN. AS BUREAU AWARE CHICAGO IN RECEIPT OF INFO PREVIOUSLY INDICATING GIANCANA PLANNING DEPARTURE CHICAGO AREA FOR PERU JANUARY 5 LAST. SAME INFORMANT ADVISED JANUARY 5 LAST HE LEARNED GIANCANA DEPARTED CHICAGO JANUARY 3 LAST IN COMPANY WITH "SLICKER SAM" ROSA FOR UNKNOWN DESTINATION. (u)

PHYSICAL SURVEILLANCE CONDUCTED O'HARE AIRPORT JANUARY 4-5 LAST DID NOT OBSERVE GIANCANA DEPARTURE. NOTED PHYSICAL SURVEILLANCE DID OBSERVE ^{DEPARTURE} RICHARD CAIN FOR MIAMI JANUARY 4 LAST AND SUBSEQUENTLY PLACED BY MIAMI DIVISION ABOARD FLIGHT FOR LIMA PERU SAME DATE. NOTED CAIN IN PERU LATTER PART 1964 LOOKING INTO BUSINESS VENTURE ON WHICH HE PREPARED REPORT SUBSEQUENTLY PRESENTED TO GIANCANA. CHICAGO ASSUMES CAIN WILL MEET WITH GIANCANA IN PERU TO PERSONALLY SHOW HIM SITUATION. (u)
