CG 6792-PC ADVISED THIS DATE THAT MEETING SCHEDULED FOR NOON THIS DATE AT "THE SPOT" RESTAURANT OWNED BY JOHNNY "HAIRCUTS" CAMPANALE WHICH TO BE ATTENDED BY APPROXIMATELY 15 OF GIANCANA'S CLOSEST ASSOCIATES. TO BE IN ATTENDANCE WERE BUTCH BLASI, QUEENIE SIMONELLI, CAMPANALE, CHUCK ENGLISH. INFORMANT STATED GIANCANA ALSO SUPPOSED TO ATTEND WAS NOT SURE WHAT EFFECT HIS APPEARANCE BEFORE GRAND JURY IN NEW YORK CITY WOULD HAVE. *u*

PHYSICAL SURVEILLANCE THAT LOCATION 1 PM REFLECTED VEHICLES OF BLASI, SIMONELLI, SAM ROSA, JOE MARKS, JOHN MATASSA. INFORMANT BELIEVED HE WOULD BE ABLE TO DETERMINE THOSE PERSONS IN ATTENDANCE AND WILL ADVISE JANUARY 15 NEXT. NATURE OF MEETING UNKNOWN BUT INFORMANT BELIEVES HE WILL BE ABLE TO DETERMINE. *u*
