CONFERENCE HELD JANUARY 26 LAST WITH USA EDWARD HANRAHAN AND AUSA DAVID SCHIPPERS RE IMPENDING GRAND JURY INVESTIGATING GIANCANA'S ACTIVITIES. SCHIPPERS ADVISED HE DESIRES TO COMMENCE APPROXIMATELY FEBRUARY 8 NEXT. SCHIPPERS ADVISED HE WOULD LIKE TO WAIT UNTIL RESULTS OF INVESTIGATION BEING CONDUCTED IN PERU ON ACTIVITIES OR RICHARD CAIN ARE AVAILABLE FEELING THIS WILL BE OF PERTINENCE IN QUESTIONING OF WITNESSES APPEARING BEFORE FGJ. *u*

SCHIPPERS DESIRES GIANCANA BE SUBPOENAED ON A SUNDAY NIGHT REQUIRING APPEARANCE FOLLOWING MONDAY MORNING, FEELING THAT IN THIS MANNER GIANCANA WILL NOT HAVE TIME TO UTILIZE LEGAL MEANS TO AVOID APPEARANCE. SCHIPPERS FURTHER REQUESTED BUREAU AGENTS SERVE GIANCANA WITH SUBPOENA. *u*

CG 6533-S ADVISED THIS DATE GIANCANA OBSERVED AT ARMORY JANUARY 23, 24, AND 26 LAST. FIXED SURVEILLANCE OBSERVING ARMORY LOUNGE 12 MIDNIGHT TO 8 AM THIS DATE NOTED NO ACTIVITY AFTER 1 AM. POLICE PATROL EXTREMELY LIGHT IN AREA. PLANT BEING MAINTAINED THIS WEEK IN ANTICIPATION OF GIANCANA'S IMPENDING DEPARTURE FOR PURPOSES OF REENTRY ARMORY LOUNGE. *u*
