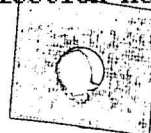
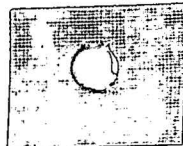

**ANTIRACKETEERING** PROPOSED MEETING OF HOODLUMS, MIAMI FLORIDA, FEBRUARY 19, 1962.  
 RE MIAMI TELETYPES 12, 13, AND 14 INSTANT AND TELEPHONE CALLS BY SAC GRAPP TO BUREAU TODAY. MM 594-C\* ADVISED INDIVIDUALS MET AT PRESENT MIAMI RESIDENCE OF JACK CERONE ON 13 LAST, DISCUSSING PROPOSED "HIT" OF FRANK. INDIVIDUALS INVOLVED IN CONTEMPLATED MURDER ARE JACK CERONE, SKIP CERONE, DAVE TARAS, PETE\*(LNU) AND INDIVIDUAL CALLED LES, BELIEVED TO BE LES KRUSE, CHICAGO HOODLUM, AND A 6TH TO DATE UNIDENTIFIED INDIVIDUAL. FOLLOWING DISCUSSION EVENING OF 13 LAST 6 INDIVIDUALS OBSERVED DEPARTING RESIDENCE IN TWO AUTOMOBILES. INFORMANT REPORTED PURPOSE OF DEPARTURE WAS TO "TAKE A RIDE" TO LOOK OVER THE ROUTE THEY WOULD TAKE DURING THE "HIT." CONVERSATION INDICATED SPOT PICKED FOR DISPOSAL OF VICTIM WOULD NECESSITATED THEIR TRAVEL ON MAIN HIGHWAY AND TRAVEL TO DANIA, FLORIDA. DANIA IS ADJOINING CITY NORTH OF HOLLYWOOD, FLORIDA. INDIVIDUALS WERE APPARENTLY GOING OVER DIAGRAM OF MAP AND DISCUSSING NECESSARY TRIP IN THAT AFTER THEY GRABBED VICTIM "WE GOT A HOT ONE, WE GOT TO GO TO DANIA (DANIA, FLORIDA). YOU CANT COME BACK TOWARD THE BEACH, THEY ARE GOING TO GIVE YOU A RAP FOR COMING BACK HERE. INDICATIONS WERE THEY HAD FOLLOWED VICTIM FOR TWO DAYS AND HAD DETERMINED FROM HIS ACTIVITY WHERE THEY ARE GOING TO FORCE HIM IN THE CAR. INFORMANT REPORTS THESE INDIVIDUALS RENTED BOAT YESTERDAY, COULD CHOP UP VICTIM WITH AX, TAKE HIM TO OCEAN IN BOAT AND DISPOSE OF PIECES. VICTIM IDENTIFIED AS FRANK S. ESPOSITO, *FLA*
