PROPOSED MEETING OF HOODLUMS
Miami, Florida, February, 1962

Top Hoodlum Program

Agents from the Chicago and New York Divisions on assignment in Miami in connection with instant case are living at the Blue Seas Motel on Collins Ave., Miami Beach.

Said Agents have observed, on a daily basis, a number of lesser hoodlums who are staying at the same motel and who often have other hoodlum visitors therein.

Contact with the motel manager, an established source, established that the following are temporary tenants and hoodlums:

- Room 223 ~~DON ROSS~~ and ~~JOE ROSS~~, Chicago, Ill., true name of either or both believed to be ~~ALTIERE~~.
- Room 315 ~~DON ANGEL~~ of 236 Clark St., Chicago. Believed to be partner in Angel-Kaplan Handicapping Service of Chicago.
- Room 317 ~~JOHN L. DANTANIO~~ and ~~SAL LEPRE~~, possibly 64 - 74 Sanders St., Rego Park, N. Y.
