MM 509-C advised on 2/20/62 that there have been some changes made in the MORRISON-COPPOLA bookmaking and betting operation at Miami Beach since MICHAEL COPPOLA (Miami file 92-101) went to jail. He advised that JOE MORRISON has moved from the Normandy Isle Golf Club, where he was operating, to the Amvets Post #35 Club, Miami Beach, where COPPOLA had been operating; BENNIE ZEEMAN was moved from the Normandy Isle Golf Club to the Patio Bridge Club, Miami Beach, where ZEEMAN will do his bookmaking; HARRY LANDAU, aka "Harry the Hat," has taken over MORRISON's operation at the Normandy Isle Golf Club and a newcomer, FRANK LUZANO or FRANK LORENZO (ph), is assisting JOE MORRISON at the Amvets Post #35 Club. far, JIMMY COPPOLA, brother of MICHAEL COPPOLA, has not paid too much attention to the bookmaking and betting operation at the Amvets Club but appears to be looking after MICHAEL COPPOLA's interest, his children and home.

This source also advised that the National Plastering Company, Miami Beach, where MAX EDER (Miami file 92-467) has a big interest, has acquired the plastering contract of the new Publix supermarket being constructed at Miami Beach. He understood SAUL EDER, brother of MAX EDER, acts as supervisor on the job and looks after MAX EDER's interest, for which he allegedly receives \$150.00 a week, and also looks for his brother, MAX, to take care of him on the profit split. He related that he was told MAX EDER hopes to make no less than \$25,000.00 to \$30,000.00 from this source this year.

MM 509-C also advised that a big blackjack game started at the Patio Bridge Club, Miami Beach, which is operated by BEN HUSICK (Miami file 162-80). He also learned that BEN HUSICK the past week has acquired half interest in the poker games operated in the same club by JACK FRIEDLANDER (Miami file 162-93).
