ADMINISTRATIVE

On December 30, 1967, PCI advised that the Dallas PD contacted him concerning GEORGE ALBERT MC GANN and he got in touch with MC GANN who then turned himself in to the Dallas PD and was released on bond. MC GANN was charged with the murder of TRUMAN CARTER in Dallas, July, 1967. believes this was done by Captain WILL FRITZ merely to make good on a boast he had previously made that he would have someone arrested for this murder before the end of the year 1967. does not feel that MC GANN will be indicted for this murder and no date was set for a hearing.

On 1/22/68, PCI was advised that MC GANN was a suspect in a recent Dallas major theft of color television sets (DL 15-6383). stated he had heard nothing about color televisions from MC GANN and MC GANN had called him 1/12/68, stating he would be out of town for a few days, but did not say where he would be.

On 2/13/68, PCI was informed that a Federal warrant is on file for MC GANN and MC GANN is a fugitive. stated he does not know where MC GANN is, but is quite certain he is out of Dallas. He stated MC GANN and his wife are together and he has known MC GANN to visit his mother in Big Spring, Texas, from time to time.
