stated on 3/12/62 that he received word that HERSHIE LAFF heard about the need for additional capital and personally contacted LOWENSTEIN, stating he had been in the construction business in Chicago, Ill., and that he had some people who were interested in furnishing the additional capital needed to get construction started. This source also said he was told that the club had received a tentative mortgage commitment of \$350,000.00 and needed about \$100,000.00 additional to get construction started. According to information received by MM 807-C, LAFF was told by LOWENSTEIN that his offer would be given due consideration and that he would see him later.
