CRIMINAL INTELLIGENCE PROGRAM, MIAMI DIVISION, AR.

ON 19 LAST MM 606-PC ADVISED ELI QUAIN, MIAMI BEACH, WHO IS REPORTED COLLECTOR OF PAYOFFS FOR LOCAL AUTHORITIES, ADVISED THERE WAS "NO MORE DEAL." INFORMANT STATES THERE IS NO MORE PAYOFF BEING COLLECTED FOR SHERIFF THOMAS KELLY, DADE COUNTY DEPARTMENT OF PUBLIC SAFETY, OR RICHARD GERSTEIN, STATE ATTORNEYS OFFICE, MIAMI, FLA., FOR PROTECTION OF BOLITA AND BOOKMAKING. INFORMANT STATES BILL DORN, WHO HAS COLLECTED FOR STATE AUTHORITIES, HAS ALSO ADVISED HE CANNOT ACCEPT ANY MORE MONEY. INFORMANT STATES MAIMI PD MONEY IS STILL BEING COLLECTED BY TILLMAN "RED" RAINWATER. BOLITA IS STILL BEING SOLD IN MIAMI AREA, HOWEVER ON SNEAK BASIS AND THE MAJOR OPERATION HAS NOW BEEN MOVED TO BROWARD COUNTY WHERE ALL OPERATORS ARE PAYING \$350 A MONTH FOR COUNTY AND STATE PROTECTION. INFORMANT STATES ABOVE ACTION REPORTEDLY TAKEN IN VIEW OF FEDERAL GOVERNMENTS PRESSURE ON GAMBLING AND BOOKMAKING IN THIS AREA.
