ReBuairtel 3/21/62, requesting complete details of information furnished by MM 606-PC concerning payoffs to local authorities.

On 2/19/62, MM 606-PC advised the bolita operators of Dade County were aggravated with JOE GORMAN, who was then supervisor of the Vice Squad of the Dade County Department of Public Safety. Informant stated GORMAN had been receiving payoff from bolita operators but had in the recent past arrested a number of the same, stating that pressure was being put on him and he could not prevent the arrest. The informant stated GORMAN would be drinking in the bar and all of a sudden would make the statement, I am going out and arrest, etc., etc., naming certain bolita operators.

Informant stated as a result the bolita operators were getting together and were going to "get up a big bundle" of money for the Sheriff, THOMAS KELLY, and have GORMAN transferred to the Narcotics Squad.

Information was received on March 9, 1962 that Sgt. JOSEPH GORMAN had been transferred from the Vice Squad to the Narcotics Squad.

On March 19, 1962, the informant advised there was no more collections being taken in Dade County for protection for bolita except for the Miami Police Department. This information was reported in Miami teletype March 20, 1962.
