violators; it has principally been under the control of MICHAEL COPPOLA and is located on property owned by JOHN ANGERSOLA, aka., John King (Miami file 92-100). MM 509-C advised the "boys" are now referring to the club as the Midtown Social Club, which presently is closed during the day but opens about six or seven p.m. and remains open until two or three a.m., depending on the activity and action in the card games. This source also advised that inasmuchaas COPPOLA is in prison, EDDIE GOLD, a bookmaker and part of the COPPOLA organization has been sending JACK GORDON over to the Sea Gull Hotel, Miami Beach, where numerous gamblers and bookmakers hang out, for the purpose of "laying off" some of the bets GOLD receives.

MM 675-C, on 3/21/62 advised he heard HAROLD SOLOMON, a bail bondsman at Miami Beach, makes a bail bond for anyone sent by JOSEPH INDELICATO (Miami file 92-404) and it is rumored that INDELICATO has some interest in the Harold Solomon Bail Bonds concern.

SKATTEGARD also stated MARZANO is the father of ALPHONSE MARZANO, Jr., age 30, of 729 NE 3rd St., Hallandale, Fla., who was arrested at Gulfstream Race Track on 3/15/62 for disseminating race results from the track by hand signals.
