WEEKLY SUMMARY

MM 673-C, on 4/18/62, advised that a new window washers' union had already held a meeting and he had heard that JOE INDELICATO (Miami File 92-404) had brought in one SAM ANDREWS from Chicago, Ill. or New York City as organizer.

Information apparently relates to the SAM ANDREWS, FBI #1728209, resident of Ft. Lauderdale, Fla., President and Business Agent of a newly-formed Local 1892, Brotherhood of Painters, Decorators and Paper Hangers, Industrial Division, which has offices at 410 N. W. 22nd Ave., Miami, Fla. This local set up a picket line on 4/6/62 at the Caribbean Towers job, being built by Frank J. Rooney, Inc.

PCI, on 3/28/62, advised that MAX EDER (Miami File 92-467) has been playing cards at the Fontainebleau Hotel, Miami Beach, Fla., card room rather regularly with NAT MODELL, a bookmaker. This source pointed out that MAX EDER has charge of the card room. He pointed out that on 3/22/62, EDER expressed dissatisfaction relative to the work of FRED CUTTER, one of the hotel employees assigned to the card room. Informant stated that on night of 3/25/62, FRED CUTTER was fired on EDER's orders.

On 4/11/62, at the residence of PASQUALE ERRA (Miami File 92-648), JOSEPH L. PAGANO, FBI #4674260, and ANTHONY SALERNO (Miami File 92-406) were observed to have conversed approximately 40 minutes.

PAGANO possibly identical to JOE PAGANO, who allegedly resides on a palatial residence at 5313 North Bay Road, Miami Beach, Fla. PAGANO was driving a 1961 Lincoln automobile bearing 1962 Fla. License 1WW-5034, which license has been issued to the Ryan Holding Corp., New York City.

MM 509-C, on 4/11/62, advised that ALLIE HARRIS, a member of the COPPOLA-MORRISON bookmaking and betting combine (Miami File 92-101) arrived in Miami on 4/10/62 from New York City. HARRIS has been in New York City operating dice games. According to information MM 509-C received, HARRIS had frequented the Amvets Post #35, Miami Beach, and intends to remain here about a week or 10 days.

On 4/16/62, MM 730-C advised he received information that from 1957-59, JOESFISCHETTI (Miami File 92-99), under the name JOES FISHER, received 71 checks from the Fontainebleau Hotel, Miami Beach, each in the amount of \$540. Since FISHER appeared on the payroll, he received these checks each 2 weeks.

Information also came to his attention that FISHER also received a check of \$2,000 from this hotel, purpose unknown.
