WEEKLY SUMMARY

Lt. GEORGE HODGES, North Bay Village, Fla. Police Department, on 4/26/62, advised he brought CHARLES TOURINE (Miami File 92-106) into his office to be photographed and at that time TOURINE stated he had no gambling interest in the United States, but had a gambling operation "going on" in London, England which he refused to discuss, which is "fronted" by an Englishman, whose name he refused to supply. TOURINE also allegedly told HODGES he intended to return to London, England, sometime during the coming week.

Suit for divorce against EUGENIO STEFANO CAMPO (Miami File 92-586) had been filed by his wife, SHIRLEY CAMPO on 1/23/62. Decree Pro Confesso entered 2/22/62. Final hearing was set for 4/20/62, however, this hearing was cancelled at the request of SHIRLEY CAMPO's attorney. Secretary to Judge MARSHALL WISEHEART, Miami, Fla. stated SHIRLEY CAMPO took that action because of CAMPO's arrest in New York City on 4/15/62, and because she felt sorry for him.

On 4/24/62, MM 509-C advised that MICHAEL COPPOLA's (Miami File 92-101) Midtown Social Club, Miami Beach, formerly known as the Amvets Post #35 Club closed on the past Monday
