CG SEVEN ZERO ONE SIX - PC ADVISED THAT HIS CLOSE ASSOCIATE IN LEADERSHIP ORGANIZED CRIME IN CHICAGO, GUS ALEX, IS CURRENTLY IN EUROPE HAVING LEFT COUNTRY ON JUNE THIRTEEN, LAST.

PC ADVISED THAT ALEX, IN ORDER TO AVOID DETECTION HERE, LEFT CHICAGO FOR ANOTHER CITY, PROBABLY NEW YORK, ON SATURDAY, JUNE THIRTEEN AND THEN LEFT COUNTRY FROM OTHER CITY FEELING HE WOULD NOT BE AS WELL KNOWN IN OTHER CITY AND COULD SLIP OUT OF COUNTRY UNNOTICED BY AUTHORITIES.

PC ADVISED ALEX INTENDS TO VISIT GERMANY AND SWITZERLAND, AMONG OTHER COUNTRIES, WHILE IN EUROPE AND WILL REMAIN THERE UNTIL ABOUT MIDDLE OF NEXT MONTH. PC STATED ALEX WAS ACCOMPANIED BY HIS WIFE, SUZANNE FUEGER ALEX, WHO IS NATIVE GERMAN.

BUREAU REQUESTED TO ALERT APPROPRIATE LEGATS FOR COVERAGE ALEX' ACTIVITIES IN EUROPE.
