ReBucab indicates ALEX and wife departed for Germany and Switzerland from New York City on 6/13/70.

The Swiss Central Police Bureau was promptly alerted, but no information has been received from them to indicate ALEX and wife came to Switzerland. This is considered highly unlikely, since Swiss have issued an entry ban against him and put his name on the list of persons to be checked if they arrive in Switzerland. His name would therefore undoubtedly have been picked up at the airport on arrival or in the hotel registry during his stay.
