GUS ALEX

On 2/17/72, LV 211-PC advised that the Hyatt Hotel chain is negotiating with the owners of the Riviera Hotel, Las Vegas to purchase the hotel. Target stated that all of the owners with the exception of the major owner, EDWARD TORRES, are extremely anxious to sell. The negotiations at the present time are for the outright purchase of the hotel, gambling casino and all physical properties. Target stated that as the negotiations stand now, the current management would be retained to operate the casino.

On 2/23/72, LV 177-C, who has considerable knowledge regarding the Riviera Hotel, confirmed that the above mentioned negotiations are taking place for the sale of the hotel.
